ARTICLES OF INCORPORATION

OF

GREEN ENTERPRISES, INC.

We, the undersigned, being four natural persons of full age, at least two-thirds of whom are residents of the United States, its territories or possession, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

I.

The name of the corporation is GREEN ENTERPRISES, INC.

II.

The purpose of this corporation is to purchase and sell farms and to engage in the business of farming and of producing, merchandising, and preserving all kinds of farm, fruit, vegetable, and garden products and of cultivating, growing, harvesting, picking, cleaning, packing, shipping, buying and selling at wholesale and retail all kinds of fruit, vegetable, farm and garden products;

To engage in the general livestock and ranching business, both on its own account and as agent; to feed, range, graze, manage, herd, control, brand, care for, purchase, market and sell livestock of every kind, both on its own account and as agent for other persons or corporations and to buy, raise, cultivate, manage, operate and sell ranch properties and products therefrom, both on its own account and as agent for other persons or corporations;

To carry on the business of resort and recreational centers, to engage in the business of selling food and beverages, to engage in the

business of leasing and renting out recreational lands with or without improvements situated thereon; and to conduct such facilities as may be necessary in connection with the same; and to do and carry on all incidental services that appertain to any of the above and to carry on any lawful business whatsoever in connection with any of the foregoing or which is calculated directly or indirectly to promote the interest of this corporation or to in any way enhance the value of this corporation.

III.

The duration of this corporation is perpetual.

IV.

The location and post office address of the registered office of the corporation in the state of Idaho is: H. C. R. 66, Box 708, Sandpoint, Idaho, 83864.

V.

The total authorized number of par value shares of stock is 100,000. The aggregate par value of the total authorized number of par value shares is \$25,000. All of the stock of the corporation shall be common stock and shall be non-assessable, and each share shall have a par value of twenty-five cents (25 ¢).


