ARTICLES OF INCORPORATION

OF

COFFLAND, BROWN, AND KOLLER, INC.

WE, THE UNDERSIGNED, being natural persons of full age, and citizens of the United States of America, have this day voluntarily associated ourselves for the purpose of forming a corporation pursuant to Idaho Code Title 54, Chapter 12, Section 54-1235, for the purpose of rendering professional civil engineering and surveying services and allied professional services. We adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name of Corporation

The name of the corporation shall be COFFLAND, BROWN, AND KOLLER, INC.

ARTICLE II

Duration

The duration of the corporation shall be perpetual.

ARTICLE III

Purposes and Powers

The corporation is formed for the purpose of rendering professional civil engineering and surveying services and allied professional services, and for the purpose of investing its funds in real estate, mortgages, stocks, bonds, or any other type of investments, and owning

such real and personal property as is necessary for the rendering of the foregoing-described services, to the extent permitted by the professional service corporation act.

This corporation shall have the power to do such acts as are necessary to accomplish said purposes, except as may be prohibited.

ARTICLE IV

Principal Office

The address of the initial registered office and the principal office of the corporation is 2005 Ironwood Parkway, Suite 125, Coeur d'Alene, Idaho, 83814.

ARTICLE V

Name of Registered Agent

The name of the initial registered agent for this corporation at the address set forth in ARTICLE IV above is Edward G. Coffland.

ARTICLE VI

ARTICLE VII

Directors

The corporation shall be governed by a board consisting of no less than one (1) and no more than five (5) directors. Directors shall be stockholders in the corporation and shall be elected by the stockholders.

The number of Directors constituting the initial Board of Directors is three (3). Those incorporators whose names and mailing addresses are set forth in the preceeding ARTICLE VI shall serve as directors until their successors are elected and qualified.

ARTICLE VIII

Capitalization

The aggregate number of shares of stock that the corporation is authorized to issue is one hundred thousand shares (100,000) which shares shall be common stock having a par value of \$1.00 per share. Stock shall not be issued to any person who under the laws of the State of Idaho is ineligible to be a shareholder of such corporation.

The corporation's Board of Directors or its shareholders may adopt bylaws restraining the alienation of shares of this corporation and providing for the purchase or redemption by this corporation of its shares; provided, however, such provisions dealing with the purchase or redemption by the corporation of its shares may not be invoked at a time or in a manner that would impair the capital of the corporation.
