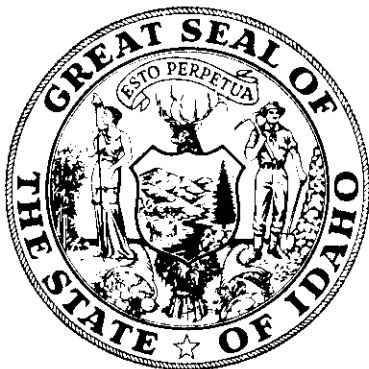

ARTICLES OF INCORPORATION

OF

RAY LARREA TRUCKING, INC.

KNOW ALL MEN BY THESE PRESENTS: That WE, the undersigned, being natural persons of full age, do hereby voluntarily associate ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and we hereby certify:

I.

The corporate name of this corporation shall be RAY LARREA TRUCKING, INC.

II.

The purposes and objects for which said corporation is formed are as follows:

a. To engage in a commercial trucking business; to haul and deliver commodities of any and all kinds within the State of Idaho and throughout the United States; to buy, sell and otherwise deal in and with tractors and trailers suitable for commercial trucking and to maintain and repair the same; and to buy, sell, lease and deal in and with real and personal property of every kind and nature upon which or in connection with which the business may be conducted, and to buy, sell, lease and exchange real property.

b. To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefor, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property

of the corporation may be so pledged, mortgaged or hypothecated.

c. To exercise generally the powers customarily exercised by business corporations, and particularly the powers provided by the laws of the State of Idaho, in any State of the United States and throughout the world.

d. To carry on any other business, or to do anything in connection with the objects and purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said objects and purposes. The foregoing clauses, by reason of the specific enumeration of powers, shall not be held to restrict the power of the corporation to do any of the things within the purview of its general purposes.

III.

This corporation shall have a perpetual existence.

IV.

The place where the principal business of this corporation shall be transacted and the post office address of its registered office shall be 105 Rosalyn Court, Meridian, Ada County, Idaho, and RAY LARREA is the registered agent at that address.

V.

The capital of this corporation shall be TEN THOUSAND (10,000) shares of no-par value common stock.

VI.

The name and post office address of each of the incorporators and the number of shares of stock subscribed by each are as follows:

VIII.

The Board of Directors by a majority vote shall have the power to repeal and amend the code of By-Laws and to adopt a new code of By-Laws.

The personal property of the stockholders of this corporation shall not be liable for the debts of this corporation.

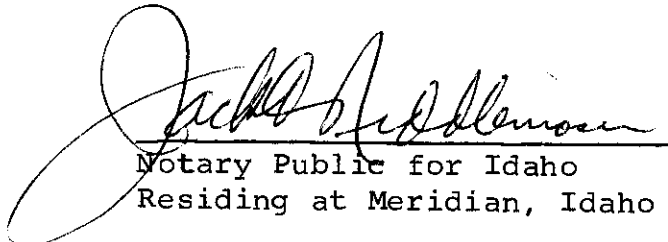
