Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is The American Land Title Company, Inc.

SECOND: Article Eighth to the Articles of Incorporation is deleted in its entirety.

THIRD: This amendment was adopted by the shareholders of the corporation on May 12th, 1995, in the manner prescribed by the Idaho Business Corporation Act.

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was 560.83; and the number of shares entitled to vote thereon was 560.83. No shares are entitled to vote as a class.

FIFTH: The number of shares voted for such amendment was 560.83; and the number of shares voted against such amendment was zero.

SIXTH: The original Articles of Incorporation are confirmed in all other respects.

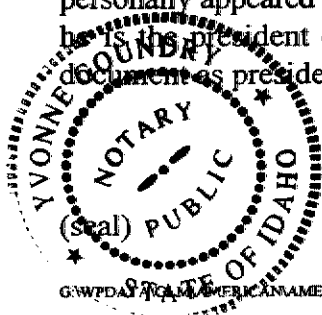
