SECRETARY OF STATE ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, subscriber to these Articles of Incorporation, being a natural person over the age of 18 years, being a Physician licensed to practice medicine under the laws of the State of Idaho, and desiring to incorporate as a professional service corporation for the purpose of providing medical services, in accordance with the Professional Service Corporations Act and the Business Corporation Act of the State of Idaho, does hereby adopt the following Articles of Incorporation and certifies that:

ARTICLE I.

The name of this Corporation shall be:

WILLIAM C. DONEHUE M.D., P.A.

ARTICLE II.

The duration of this Corporation shall be perpetual.

ARTICLE III.

The purposes for which this Corporation is formed are:

- a. To Render medical service to the general public, specifically the general practice of medicine and obstetrics.
- b. To transact any or all lawful business pertaining to the purpose described above in paragraph a as limited by Section 3-1304 of the Idaho Code.

ARTICLE IV.

This Corporation shall have an aggregate number of 6 shares of stock each of the par value of \$1,000.00.

ARTICLE V.

The address of the Corporation's initial registered office shall be 222 6th Avenue West, Jerome, Idaho 83338. The registered agent of the Corporation at said address is William C. Donehue.

ARTICLE VI.
