



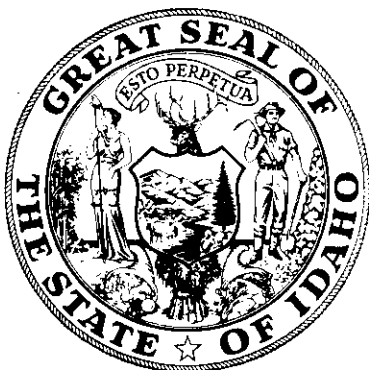
CERTIFICATE OF WITHDRAWAL
