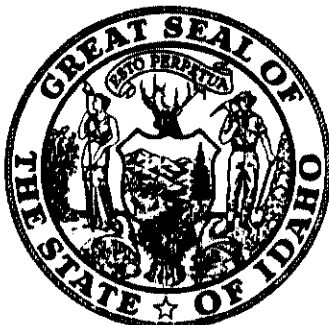
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Salmon River Helicopters, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose of purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The type and aggregate number of shares which the corporation shall be entitled to issue are one thousand shares of common stock, with a par value of \$1.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: There are no provisions for the regulation of the internal affairs of the corporation.

SEVENTH: The address of the initial registered office of the corporation is P. O. Box 1293, Riggins, Idaho 83549 and the name of the initial registered agent is Guy M. Carlson II, whose address is P. O. Box 250, Riggins, Idaho.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two and the names and addresses of the persons who are to serve as directors until the

first annual meeting of shareholders or until their successors are elected and shall qualify are:


