ARTICLES OF INCORPORATION

The undersigned, acting as incorporators under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of the corporation is D & D TRUCKING, INC.

ARTICLE TWO - DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE - PURPOSES AND POWERS

The purposes of the corporation and its powers are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE FOUR - STOCK

The aggregate number of shares of stock which the corporation shall have authority to issue is 500, and such shares shall be of no par value. Said shares of stock shall be fully paid for before being issued, and after issuance shall be nonassessable. Shareholders shall have a preemptive right to acquire unissued or treasury shares under such terms and conditions as the Board of Directors may fix for the purpose of providing a fair and reasonable opportunity for the exercise of such right. Such preemptive right

shall exist in all events, including, but not limited to:

- (1) To acquire any shares issued to directors, officers or employees;
- (2) To acquire any shares sold otherwise than for cash; and
- (3) To acquire any shares issued to satisfy conversion or option rights granted by the corporation on previously authorized sales.

ARTICLE FIVE - LOCATION

The location and address of the initial registered office of the corporation is 416 West U. S. Highway 26, Blackfoot, Idaho 83221, and the name of its initial registered agent at such address is David E. Roberts. The mailing address of the corporation shall be P. O. Box 889, Blackfoot, Idaho 83221.
