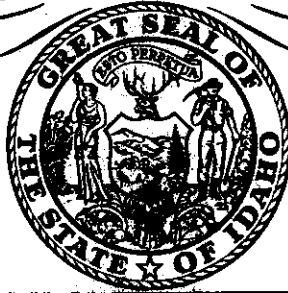

#### **NORTSIDE CHURCH OF CHRIST, INC.**

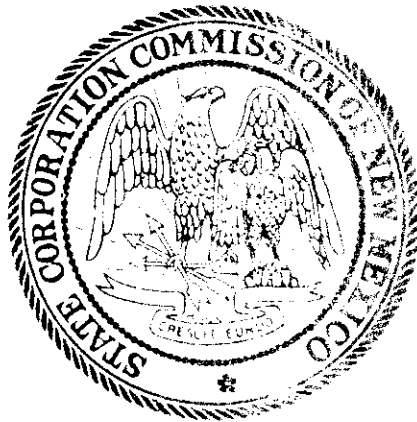
