ARTICLES OF INCORPORATION 29 10 02 AM '88

The undersigned, acting as incorporator of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be Horseshoe Bend Emergency Medical Technicians Ambulance, Inc.

ARTICLE II

This corporation is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The purpose or purposes for which this corporation are formed are to provide emergency ambulance service and emergency ambulance equipment for the citizens of the City of Horseshoe Bend and those immediately surrounding the community. Additionally, this corporation is to educate the public about first aid and medical type of knowledge, to raise funds for the ambulance and ambulance service and education for members to staff the ambulance and ambulance service and to provide education and training for emergency first aid services and general medical knowledge as may be necessary to provide service for the ambulance and its first aid needs, to promote the general health and welfare of the citizens of Horseshoe Bend, Idaho.

Notwithstanding any of the provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of the corporation shall be the carrying on the propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of any candidate for public office.

ARTICLE V.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV above.

ARTICLE VI

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954, as from time to time amended, as the Board of Directors shall determine.

ARTICLE VII

This corporation shall have members who shall elect the Board of Directors of the corporation.

ARTICLE VIII

The management of the affairs of the corporation shall be vested in the corporation's Board of Directors.

ARTICLE IX

The street address of this corporation's initial registered office is Box 81, Horseshoe Bend, Idaho, and the name of its initial registered agent is Kathryn Drake.

ARTICLE X

The number of directors constituting the initial Board of Directors is three (3), and the names and addresses of the directors constituting the initial Board of Directors are:
