SECOND. The purpose for which it is formed is: "To contract for the erection, construction, or repair of any building, structure or improvement, public or private, and erect, const ct or repair same or any part thereof, and to acquire, own, prepare for use any materials for said purposes."

FOURTH. The term for which it is to exist is Fifty years.
