ARTICLES OF INCORPORATION

OF THE

SNAKE RIVER ASSOCIATION

OF THE

USA AMATEUR BOXING FEDERATION, INC.

(A Non-Profit Corporation)

The undersigned, acting as incorporators of a non-profit corporation, adopt the following Articles of Incorporation for such corporation:

FIRST, the name of this corporation shall be the Snake River Association of the USA Amateur Boxing Federation, Inc., hereinafter referred to as the Association.

SECOND, the purpose for which the Association is organized is to foster, develop, promote, and govern recreational and competitive amateur boxing opportunities for all member athlete and non-athlete participants at local, regional, national, and international levels in accordance with the rules and regulations promulgated by the International Amateur Boxing Association, the USA Amateur Boxing Federation, and the Association.

THIRD, the Association shall have the power to do all lawful acts necessary or desirable to satisfy its purposes consistent with the provisions of Title 30, Chapter 10, of the Idaho Code and Section 501(c)(3) of the Internal Revenue Code of 1954, as amended (IRC). Notwithstanding any other provisions of these Articles, the Association shall not pursue any activities not permitted by a corporation exempt from federal income tax under Section 501(c)(3) of the IRC and from state income tax.

FOURTH, all registered athletes and non-athletes shall be members of the Association. Those members who are ages 16 and older shall have one (1) vote.

FIFTH, all provisions of these Articles shall be subject to amendment, consistent with the provisions of Title 30, Chapter 10, of the Idaho Code and Section 501(c)(3) of the IRC, by vote of the members entitled to vote in attendance at the annual meeting or any special meeting.

SIXTH, upon dissolution, the assets of the Association shall be distributed by the Board of Directors in accordance with the restrictions of Section 501(c)(3) of the IRC and Idaho Law.

SEVENTH, the affairs of the Association shall be managed by a Board of Directors in accordance with the bylaws of the Association which may be amended as needed. The Board shall consist of not less than five (5) directors.

EIGHTH, the registered office of the Association shall be 839 W. Bonneville, Pocatello, Idaho 83204, and its initial registered agent shall be Mike Divin.


