

ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

UTAH-IDAHO SOUTHERN BAPTIST CONVENTION

Pursuant to the provisions of Section 16-10-57 of the Utah Business Corporation Act, the undersigned corporation hereby adopts the following Article of Amendment to its Articles of Incorporation:

FIRST: The name of this corporation is:

UTAH-IDAHO SOUTHERN BAPTIST CONVENTION

SECOND: The following amendment to the Articles of Incorporation was unanimously duly adopted by the Executive Board of this corporation on September 5, 1966, and duly adopted by the written consent of a majority of the messengers pursuant to a special meeting duly called for that purpose on the 23rd day of September, 1966, all in accordance with the Utah Business Corporation Act:

"This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and it is organized solely for nonprofit purposes. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to Southern Baptist Foundation, 460 James Robertson Parkway, Nashville, Tennessee, which is organized and operated exclusively for charitable, educational and religious purposes and which has established its tax-exempt status under Section 501 (c) (3) of the Internal Revenue Code. If this corporation holds any assets on trust, such assets shall be disposed of in such manner as may be directed by decree of the district court of the county in which this corporation's principal office is located, upon petition therefor by the Attorney General or by any person concerned in the liquidation."

THIRD: The number of shares of this corporation outstanding at the time of such adoption, and the number of shares entitled to vote thereon was:

This corporation is a nonprofit corporation without capital stock, and the members of this corporation are composed of those persons duly slected and certified to by the Baptist Churches affiliated with this corporation, which persons are referred to as messengers. Each affiliated church is entitled to three messengers and one additional messenger for every fifty, or major portion thereof, resident members of each affiliated church; provided, however, that in no event shall any affiliated church have more than ten messengers.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:
