ARTICLES OF INCORPORATION OF ASSEMBLY OF GOD CHURCH

KNOW ALL MEN that we, the undersigned, all of whom are residents of the state of Idaho, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the state of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter setforth, a religious corporation to be known as Assembly of God Church.

Article I.

The name of this corporation shall be ASSEMBLY OF GOD CHURCH, INC.

Article II.

The principal place of business of this corporation shall be in the city of Coeur d'Alene, County of Kootenai, State of Idaho.

Article III.

The term of the incorporation shall be perpetual.

Article IV.

The objects for which this corporation is formed are:

To preach and teach the word of God; to do missionary work all over the world and general religious work everywhere.

To purchase, own, hold, sell, convey, mortgage or otherwise hypothecate real estate and personal property of all kinds and descriptions necessary or incident to, or in connection with its church work.

Article V.

That the number of directors who shall have the management of its affairs as aforesaid shall be, and the names of the directors elected for the first year are:

That a majority of said members were then and there present and voted, at said election, for the above named directors, as is more particularly setforth in the certificate and verification of the officers who conducted the election hereto annexed and made a part of these articles. That notice of the meeting so held was in words and figures as follows:

NOTICE

Notice is hereby given that an election will be held at a meeting of the members of the Assembly of God Church at the hour of 7:30 o'clock P. M. on Tuesday evening, November 10, 1936, at the Church of the Truth building on the corners of Sixth street and Garden Avenue, Coeur d'Alene, Idaho, for the purpose of electing directors and such other boards as may be deemed proper in connection with the incorporation of this body.

That said notice was published once each week for the period of three consecutive weekly publications, to-wit: October 23, 1936, October 30,1936 and November 6, 1936, in the "Kootenai County Leader," a newspaper printed and published weekly in Coeur d'Alene, Kootenai County, Idaho, said newspaper having a general circulation in said county, and having been continuously and uninterruptedly published in said Kootenai County during a period of more than seventy-eight weeks immediately prior to the first publication of said notice.

That said notice was also posted in a conspicuous place on the building where such election was held for more than

two weeks next immediately preceding the date of said election. Article VI.

The affairs of this corporation shall be managed by a Board of Directors consisting of three in number. Other officers may be elected such as may be deemed necessary by the members. The said Board of Directors and other officers shall be elected annually by the members of this corporation, from its membership, at their regular annual meeting.

Article VII.

The terms of admission to this body are and shall be:
