ARTICLES OF INCORPORATION

FOR

SECTION OF

SPECIAL ASSISTANCE SERVICES CORPORATION

We the undersigned, incorporators, do hereby associate ourselves together to form and establish a non-profit corporation under the provisions of the corporation laws and other statutes of the State of Idaho and for that purpose state:

ARTICLE I

The name of this Corporation shall be Special Assistance Services Corporation.

ARTICLE II

The period of duration of the Corporation shall be perpetual and the Corporation has no stated capital.

ARTICLE III

The purpose for which this Corporation is formed is to solicit, request, receive, and administer, funds from private businesses, industries, organizations, associations, corporations, and individuals, for humanitarian reasons in order to give temporary financial assistance to those persons to whom no other source or avenue of financial aid is available. The need for such help must be immediate and distressing. Non-liquid assets shall not be a factor in determining need.

As an amplification of said purposes and without in any way limiting same, it is contemplated that the further purposes of this Corporation shall be:

To provide monetary grants:

1. for educational purposes, for a student whose educational future is in jeopardy.
2. for temporarily disabled victims of accident, illness or abuse.
3. for dental, ocular, and audio needs including prosthetic devices.

Limitations, processes, and procedures, for administering grants shall be determined and provided for in the by-laws of this Corporation.

To hold title to real, personal, and tangible property and investments and to take all steps permitted by Idaho statutes to manage and control such properties and investments in order to improve the financial stability and position of this Corporation to expand and implement the purposes for which it was formed.

To enter into contractual arrangement with any person, corporation, partnership, or company, for products or services deemed essential to properly effectuate the purposes of this Corporation.

#### ARTICLE IV

It is not the purpose of this Corporation to:

1. supplant the activities or funds of State or Federal agencies, or the activities or funds of any charitable organization, institution, or philanthropic individual.
2. finance catastrophic medical expenses.
3. participate in, or contribute to, the funding of any other non-profit organization or corporation.
4. provide financial aid for the taking of life, including the unborn, in any way or for any reason.
5. provide funds for failing or financially troubled businesses.

Any additional limitations shall be specified in the by-laws of this Corporation.

#### ARTICLE V

Any person or persons obtaining help from this Corporation by submitting false information or using such aid in any way other than the avowed purpose or need shall be prosecuted for fraud.

Anyone requesting assistance must be informed in writing of this Article before any action may be taken in their behalf.

#### ARTICLE VI

This Corporation shall have no members (Subsection (c) of Section 30-308 of Title 30--Chapter 3 of the Idaho Code).

The Board of Directors of this Corporation shall be elected pursuant to Subsection (e) of Section 30-314 of Title 30--Chapter 3 of the Idaho Code.

#### ARTICLE VII

The governing body of this Corporation shall be the Board of Directors.

The number of the initial board shall be three (3).

#### ARTICLE VIII

This Corporation shall not have the authority to issue capital stock.

#### ARTICLE IX

Assets and funds of this Corporation shall be used for:

1. the purposes set forth in Article III of these Articles of Incorporation.

2. payment of operating expenses and salaries incurred in the normal operation of this Corporation's affairs.
3. payment of reasonable compensation to the Board of Directors for the time spent and expenses incurred while conducting the affairs of this Corporation.
4. legal and accounting fees and expenses.
5. equipment and expenditures necessary to implement and expedite the activities for which this Corporation was formed.

#### ARTICLE X

No part of the activities of this Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. This Corporation shall not carry on any other activity not permitted to be carried on by a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law.
