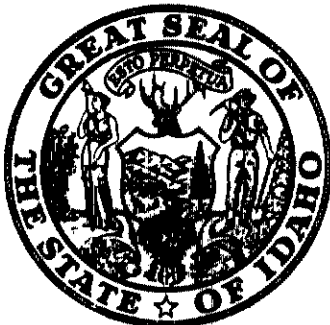

ARTICLES OF INCORPORATION
OF
B&J MANAGEMENT, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, in order to form a corporation for the purpose hereinafter stated, pursuant to the Idaho Business Corporation Act, as now in effect or as may hereafter be amended, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be B&J Management, Inc.

ARTICLE II

The period of duration of this corporation shall be perpetual.

ARTICLE III

The purpose for which this corporation is organized is stated to be for the transaction of any or all lawful business for which corporations may be incorporated in the State of Idaho.

ARTICLE IV

The aggregate number of shares which this corporation shall have the authority to issue is ONE HUNDRED THOUSAND (100,000) shares, consisting of two (2) classes, ONE THOUSAND (1000) shares of VOTING stock, and NINETY NINE THOUSAND (99,000) shares of NON-VOTING stock, all having a par value of \$1.00 each, non-assessable when paid in full.

ARTICLE VII

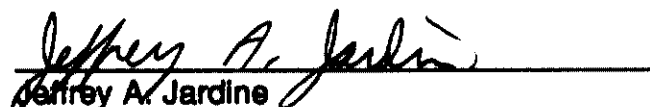
The private property of the stockholders of this corporation shall not be subject to the payment of the corporate debts in any amount or to any extent whatever.
