ARTICLES OF INCORPORATION S

OF

CAPITAL CARE CENTER, INC.

The undersigned, natural person of the age of twentyone years or more, acting as incorporator under the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1: The name of this corporation is CAPITAL CARE CENTER, INC., and its duration shall be perpetual.

ARTICLE 2: The purpose or purposes for which the corporation is organized is to engage in a nursing home business, and any lawful activity for which corporations may be organized under Idaho law.

ARTICLE 3: The aggregate number of shares which the corporation shall have authority to issue is 500 shares of capital common stock without par value.

ARTICLE 4: The address of the initial registered office of the corporation is 300 N. 6th Street, Boise, Idaho 83701, and the name of the initial registered agent at such address is C T Corporation Systems.
