ARTICLES OF INCORPORATION

OF

INLAND CONSTRUCTION, INC.

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is INLAND CONSTRUCTION, INC.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.
