KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho; AND WE HEREBY CERTIFY:

First. That the name of said corporation is CURRAN AND COMPANY, LIMITED.

Second. That the purposes for which it is formed are to carry on the business of buying and selling of Drugs and General Merchandise.

Third. That the place where its principal business is to be transacted shall be in the Town of St. Anthony, County of Fremont, State of Idaho.

Fourth. That the term for which it is to exist is fifty (50) years from and after the date of its incorporation.

Fifth. That the number of its Directors shall be five (5), and that the names and residence of those who are appointed for the first year are:


