# ARTICLES OF INCORPORATION

OF

### CLEAR CREEK AUTO REPAIR INCORPORATED

KNOW ALL MEN BY THESE PRESENT That we, the undersigned, citizens of the United States and of lawful age, have today voluntarily assoicated ourselves for the purpose of forming a profit coopertice association under the provision of Chaper 1#, Title 30, Idaho Code, and all other laws of the State of Idaho pertaining thereto, and we hereby certify as follows:

#### ARTICLE I

The name of this corportation shall be: Clear Creek Auto Repair, Incorporation

#### ARTICLE II

The purpose of this corportation shall be:

- A. To establish and provide responsible services, connected with the up keep and maintenance of automobiles, snowmobiles, trucks, and farm equipment, for any person who seeks or engage the service available.
- B. To acquire title and hold title to such real and personal property as may be necessary or desirable to carry out its purpose, and to manage and operate any real or personal property given and devised to or acquired by the corporation.
- C. To do any and all things convenient and incidental to the purpose of the corporation and generally to have and to exercise all such powers as are by law conferred upon such corporation of like character.
- D. And in carrying out the purpose of the corporation to do any and all things and exercise any and all powers not prohibited by law.

# ARTICLE III

The period of existence and the duration of the life of this corporation shall be until such time as the Board of Directors, by two-thirds vote disolve this corporation.

#### ARTICLE IV

The rights and interests of all members of this association shall be equal and no member can have or acquire a greater interest therein than any other member.

#### ARTICLE V

The number of directors of this corporation shall be four (4) members. The additional qualifications, the terms of office, manner of election, time and place of calling meetings, and the poweres and duties of the directors, shall be prescribed in the By-Laws of this corporation. Except as otherwise provideded in the Articles of Incorporation or By-Laws, the Board of Directors shall have power to conduct all of the affairs of the corporation.

# ARTICLE VI

The officers of this Corporation shall be a Chairperson, Vice Chairperson, Secretary and Treasurer. The duties and powers of the officers shall be as set forth in the By-Laws.

# ARTICLE VII

An annual meeting of the membership of the Corporation shall be held upon a date provided for in the By-Laws of the Corporation.

#### ARTICLE VIII

These Articles of Incorporation may be amended after approval by twothirds of the Board of Directors.

#### ARTICLE IX

In the event of dissolution of the Corporation, or upon its ceasing to carry out the objectives and purposes herein set forth, the property and assets then owned by the Corporation shall be divided equally between the four (4) individuals listed as Directors of this Corporation.
