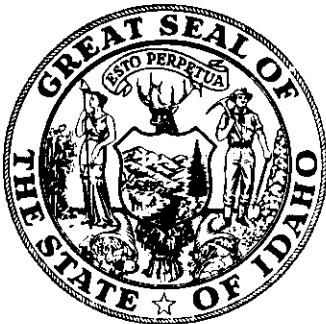

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

INDUSTRIAL SUPPLY OF COEUR D'ALENE, INC.

Articles of Amendment to the Articles of Incorporation of INDUSTRIAL SUPPLY OF COEUR D'ALENE, INC., are herein executed by said corporation pursuant to the provisions of Idaho Code, 30-1-59 through 30-1-62, as follows:

1. The name of the corporation is INDUSTRIAL SUPPLY OF COEUR D'ALENE, INC.

2. The amendment to the Articles of Incorporation of said corporation is as follows:

Article I of the Articles of Incorporation of INDUSTRIAL SUPPLY OF COEUR D'ALENE, INC., are hereby amended by the deletion in its entirety of Article I and the substitution of the following Article I for said deleted Article I:

ARTICLE I.

The name of this Corporation shall be ISCO-CDA, INC.



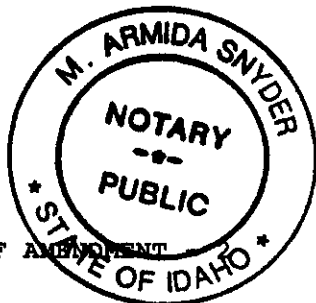


