

Pursuant to the provisions of Idaho Code §§ 30-326 and 30-327 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is BIBLE MISSIONARY CHURCH, INC., OF COUNTY OF CANYON, STATE OF IDAHO.

SECOND: The following amendments and additions to the Articles of Incorporation were adopted by the members of the corporation at a special meeting held on the ______ day of ______, 1991, with a quorum being present and voting, and the amendments and additions receiving a unanimous vote in favor thereof in the manner prescribed by the Idaho Business Corporation Act:
