### CERTIFICATE OF INCORPORATION

was filed in the office of the Secretary of State on the **Twenty-second** day of **December** A.D. One Thousand Nine Hundred **Sixty** and duly recorded on Film No. **113** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Roberts** in the County of **Jefferson**

ARTICLES OF INCORPORATION OF  
WEST-SIDE PRODUCE CO.

KNOW ALL MEN BY THESE PRESENTS:

That we, WILLIAM JARDINE, RALPH JARDINE, LYNN HANSEN, JOSEPH HANSEN, JUNIUS TAYLOR, GLEN ELLIS, MILBURN HIX And LOWELL HIX of RFD, Jefferson County, Idaho, all being persons of full age and citizens of the United States of America, do hereby, as Incorporators thereof, form a corporation under the provisions of the Laws of the State of Idaho, and we do hereby adopt Articles of Incorporation of such Corporation as follows:

ARTICLE 1  
Name and Purpose

That the name of this Corporation is West-Side Produce Co. and that the purposes for which the said Corporation are formed are as follows:

1. To engage in the business of buying and selling potatoes, but with the powers nevertheless to deal in other products such as wheat, corn, oats and grains of every description, and in connection therewith and subject to the limitations provided by law, to act as agent or broker in connection with the purchase or sale of all types of real and personal property of whatsoever kind and to apply for and obtain any and all governmental permits needed for the purposes in connection therefore. To store, warehouse, deal in and handle in any manner, potatoes, and all types of grains and vegetables; to own, lease or otherwise hold, elevators, mills, granaries, potato cellars, potato warehouses, offices and other structures of every kind and nature for the storing, handling, utilization and sale of such agriculture products of every kind and nature; to carry on a milling, manufacturing and processing business and the business of transporting agricultural products of every nature and kind, to manufacture, buy, sell and deal in agricultural machinery and milling machinery and machinery for handling potatoes, ~~oats~~ and grains and all other agricultural products and machinery for converting agricultural products of all kinds into their various products and by-products.
2. To acquire farm property and other real estate by lease, purchase and otherwise; to improve and develop the same and thereon to plant, sow, cultivate and harvest potatoes, grain, hay, forage, vegetables and all kinds of farm products and products of the soil. To breed, raise, buy, pasture, prepare for market, exhibit, sell and deal in the livestock of all kinds. In general, to conduct in all its

several departments and operations the business of farmers, fruit growers, stock raisers and to do everything incidental or conclusive to the full accomplishment of the foregoing purposes.

3. To acquire, hold, process and own patents, improvements, and franchises or to acquire licenses under such patents for the manufacture and sale of any and all machinery or improvements thereon or articles of any nature, and to beneficially use rights under such patents by vending said patents or rights or licenses thereunder.
4. To borrow money and to issue bonds, debentures and other obligations of the corporation and to mortgage or pledge its property to secure such borrowed money or other obligations.
5. To buy, own, sell, mortgage, convey, lease, rent, transfer, assign, deliver or pledge, real and personal property of all kinds and nature, including but not limited to all types of farm machinery and equipment, building and construction tools and such other property as is or may be handled, used or employed in and about such businesses.
6. To acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign, and to organize or cause to be organized, incorporate and reorganize subsidiary corporations and associations for any purpose permitted by law, to the same extent that a natural person might or could do to act as agent, factor or assignee of any person, firm or corporation; and to carry out any and all objectives or purposes as principal factor, agent, contractor, assignee or otherwise.
7. To particularly have all of the powers and authorities and provided by Section 30-114 of the Idaho Code, and the Acts amendatory thereto.
8. To exercise and perform any and all of the hereinbefore mentioned and described powers and matters within and without the state of Idaho.

#### ARTICLE 2 Duration

The duration of the said corporation shall be perpetual.

#### ARTICLE 3 Situs

That the location and Post Office address of the registered office of said corporation in Idaho shall be at Roberts, Jefferson County, Idaho.

#### ARTICLE 4 Stock

That the shares of stock of said corporation are not to

be classified and shall all be common stock and, that the authorized shares of said corporation shall be 480 of the par value of \$100.00 each, and of the aggregate par value of \$48,000.00.

The said shares of stock shall be fully paid up before issued and after issuance shall be non-assessable.
