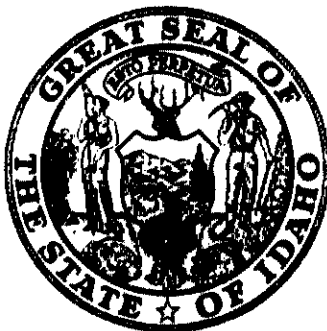
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

K&J FOOD MARKETING, INC.

The undersigned, acting as incorporator of K&J FOOD MARKETING, INC. , a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is K&J FOOD MARKETING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act and as such may be amended.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares of common stock of a par value of \$1.00 per share, an aggregate total capital of ONE HUNDRED AND NO/100 DOLLARS (\$100.00).

FIFTH: Provisions denying preemptive rights are: There are no preemptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The By-Laws shall set the number of and qualifications of Directors and Officers and shall set forth any restrictions, if any, on the transfer of shares.

SEVENTH: The address of the initial registered office of the corporation is 1701 Regal Drive, Boise, Idaho 83704 and the name of its initial registered agent at such address is Kay Johnson.


