ARTICLES OF AMENDMENT AND RESTATED ARTICLES OF INCORPORATION WITH ARTICLES OF MERGER OF THE O KI KA COUNCIL, CAMP FIRE, INC. AND THE MA TRE VAL COUNCIL CAMP FIRE, INC. AND TO CHANGE THE NAME OF THE NEW MERGED ORGANIZATION TO CAMP FIRE BOYS AND GIRLS, WA-KI-YA COUNCIL, INC. A NONPROFIT CORPORATION

KNOW ALL PERSONS BY THESE PRESENTS:

We, the undersigned, citizens and residents of the State of Idaho and the United States of America, over the age of twenty-one (21), for the purpose of Amending the Articles of Incorporation, restating the Articles of Incorporation, and filing Articles of Merger, of the O Ki Ka council, Camp Fire, Inc. and the Ma Tre Val Council Camp Fire, Inc. to change the name of the new merged organization to Camp Fire Boys and Girls, Wa-Ki-Ya Council, Inc., a nonprofit corporation under the provisions of the Idaho Nonprofit Corporation Act (Title 30, Chapter 3, Idaho Code, §§ 30-301 to 30-322) and all laws amendatory and supplementary, and for such purpose, do hereby make, adopt, acknowledge, certify, sign and file these amended, restated, and merged Articles of Incorporation for that purpose as follows:

# AMENDED ARTICLE OF INCORPORATION AND MERGER I

#### Plan of Merger

The Ma Tre Val Council Camp Fire, Inc. primary area of service is the Boise, Treasure Valley, Twin Falls and Magic Valley areas. The O Ki Ka Council Camp Fire, Inc. primary area of service is the Pocatello and Southeastern Idaho area. # AMENDED ARTICLE OF INCORPORATION AND MERGER II Approval of Members

The approval of the members is not required because the organization is under the control, direction, and auspices of the national office of Camp Fire Boys and Girls. The Camp Fire Boys and Girls national organization has approved this merger of these two organizations.

Further, the Board of Directors and members of both organizations, O Ki Ka Council and Wa-Ki-Ya Council have approved a statement of the plan of merger by a vote of the members and Board of Directors. The designation, number of members outstanding, number of votes entitled to cast each class entitled to vote separately on the plan and number of votes of each class

undisputedly voting for the plan, and the number of votes cast for or against the plan is set out in the resolution approving the merger of these organizations.

# AMENDED ARTICLE OF INCORPORATION AND MERGER III Name of Merged Corporation

The name of this Corporation is to be Camp Fire Boys and Girls, Wa-Ki-Ya Council, Inc.

# AMENDED ARTICLE OF INCORPORATION AND MERGER IV Purpose

The purpose for which the Council is formed is exclusively charitable and educational in accordance with § 501(c)(3) of the Internal Revenue Code of 1954. Any references herein to any provisions of such Code shall be deemed to mean such provision as now or hereafter existing, amended or supplemented, or superseded, as the case may be.

None of the assets or earnings of the corporation shall be paid or accrued for the benefit of any of its members, directors, officers or employees or any other individual, whether before, upon or after dissolution or liquidation, except as reasonable compensation for services rendered, property transferred or as reimbursement for expenses incurred in conducting its affairs.

The purpose for which this Corporation is formed is to serve as a chartered council of Camp Fire Boys and Girls to provide the Camp Fire program throughout its jurisdiction and to work to improve conditions in society that affect youth in accordance with

the purpose of Camp Fire Boys and Girls. The specific purposes of the Corporation are:

- a) To provide, through a program of informal education, opportunities for youth to realize their potential and to function effectively as caring, self-directed individuals responsible to themselves and to others; and, as an organization, to seek to improve those conditions in society which affect youth.
- b) To achieve this purpose, Camp Fire Boys and Girls, working with individuals, communities, and society as a whole, shall encourage the development and preservation of spiritual and ethical values; the realization of the dignity and worth of human barriers elimination of based individual: the assumptions which prejudge individuals; the practice of responsible citizenship exemplifying the highest standards of a free and democratic society; the wise use of human and natural resources; and shall provide experiences which stimulate curiosity and learning; provide renewal and adventure; develop sensitivity skills in human relationships, initiative, self-reliance, a positive selfimage and responsible attitudes; encourage an understanding and appreciation of the environment, the development of skills in outdoor living, and the search for and maintenance of optimum health of boys and girls.

#### AMENDED ARTICLE OF INCORPORATION III

#### **Powers**

In furtherance of its purpose, the Corporation shall have the following powers:

- a) To hire, lease, buy, inherit or otherwise acquire, own and hold, and invest its funds in lands, buildings, equipment or other real or personal property for an office, program facility or similar purpose for the use and benefit of said Corporation; to build, construct, operate and manage said property for the benefit of Camp Fire; and to rent, lease, mortgage or sell all or any part of such real or personal property acquired by said Corporation.
- b) To do, perform and supervise any and all things in furtherance of the general purposes hereinbefore expressed and not inconsistent with the statutes of the State of Idaho, and to have and to exercise all the powers conferred by the laws pursuant to, and under which, this Corporation is formed, as such laws are now in effect and may at any time hereafter be enacted or amended.
- c) To have all powers of any corporation to do any and all lawful actions in the State of Idaho, including but not limited to those of a nonprofit corporation under Idaho Code § 30-3-24 now or as hereinafter amended.

# AMENDED ARTICLE OF INCORPORATION IV

#### Street Address of Office and Agent

The street address of the initial registered office of the Corporation is:

# AMENDED ARTICLE OF INCORPORATION V

# Directors of Corporation

The Directors constituting the Board of Directors of the Corporation shall be between five and forty-nine.

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that such person is or was a Director or officer of the corporation shall be indemnified by the corporation against any and all reasonable expenses, including attorney fees, incurred in connection with the defense or settlement of such action, suit or proceeding; except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that the Director is liable for intentional misconduct or gross negligence. The Board of Directors may establish insurance to ensure this indemnification, as they deem necessary, in the Bylaws of this Corporation.

# AMENDED ARTICLE OF INCORPORATION VI

### Meetings

There shall be at least one meeting of the directors of the Corporation each year. Further, the Corporation shall have other annual meetings, special meetings, and other meetings as required by the Idaho Nonprofit Corporation Act.

# AMENDED ARTICLE OF INCORPORATION VIII

#### Dissolution

In the event of the dissolution or final liquidation of the corporation, after all liabilities and obligations of the

corporation have been paid, satisfied and discharged, or adequate provision made therefore, all remaining property and assets of the corporation shall be distributed, conveyed, assigned or transferred to another Camp Fire council that is acquiring the jurisdiction or such remaining assets shall be transferred to Camp Fire Boys and Girls to administer according to the Bylaws of Camp Fire Boys and Girls.

Further, upon the dissolution of this corporation, all assets shall be distributed for one or more exempt purposes within the meaning of § 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code) as discussed above, and in the event that Camp Fire Boys and Girls no longer exists, they shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## AMENDED ARTICLE OF INCORPORATION IX

#### Term

This Corporation shall have perpetual existence, provided that a charter from Camp Fire Boys and Girls is held by the Corporation.

### AMENDED ARTICLE OF INCORPORATION X

#### Amendments

These Articles may be amended by a two-thirds vote of the directors voting at a meeting of the Council, provided that the proposed amendment shall have been included in the notice of the meeting of the directors.
