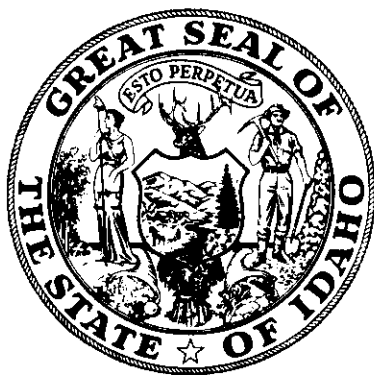

ARTICLES OF INCORPORATION
OF
KOCH LUMBER & IMPLEMENT, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age and being a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby adopt the following articles of incorporation, to-wit:

I

NAME

The name of this corporation shall be Koch Lumber & Implement, Inc.

II

PURPOSES

The purposes for which this corporation is formed are as follows:

(a) To engage in the general business of dealing in and with lumber and wood products of all types and descriptions, manufacturing, buying and selling, either at wholesale or retail, and for the purpose of buying, selling, leasing, designing, repairing or otherwise dealing in and with all types of motor vehicles, farm equipment and machinery, building supplies and supplies of all other types and descriptions, and for the purpose of engaging in such other lawful businesses as the Board of Directors may from time to time determine, and this corporation shall have all of the statutory powers conferred upon corporations by Title 30 of the Idaho Code, as it now exists or may hereafter be amended.

III

DURATION

The period of existence and duration of this corporation shall be perpetual.

IV

REGISTERED OFFICE AND AGENT

The location and post office address of the principal place of business and registered office of this corporation shall be Hammett, County of Elmore, State of Idaho. The name of the registered agent of the corporation, who may be found at that address, is Karl E. Koch, whose post office address is Post Office Box 4, Hammett, Idaho 83627.

V

CAPITAL STOCK

The capital stock of this corporation shall consist of 1,000 shares of common stock without par value. No distinction shall exist between the shares of the corporation and all such shares shall have the same rights in the corporation. All or any portion of the capital stock may be issued for cash or in payment for real or personal property, services or any other right or thing of value, for the uses and purposes of the corporation, and when so issued shall become and be fully paid the same as though paid for in cash, and the board of directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock. Such stock shall not be issued until fully paid for and once so issued shall be nonassessable.

VI

INCORPORATORS

VII

GOVERNING BODY

The governing body of this corporation shall consist of a board of one director, who shall be elected annually as provided by the by-laws. The number of the board of directors may be changed from time to time as prescribed by the by-laws, but shall be not less than one nor more than seven. The name and post office address of the initial director of the corporation appointed by the incorporator to serve until the first election of directors, are as follows:

VIII

PRIVATE PROPERTY OF STOCKHOLDERS

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation.

IX

POWERS OF THE BOARD OF DIRECTORS

In addition to other powers, the board of directors is authorized to make, alter or amend the by-laws of the corporation, to fix the amount of capital stock to be reserved as working capital or treasury stock, over and above its capital stock paid in, and to authorize and cause to be executed mortgages, liens or other encumbrances on the real and personal property of the corporation.

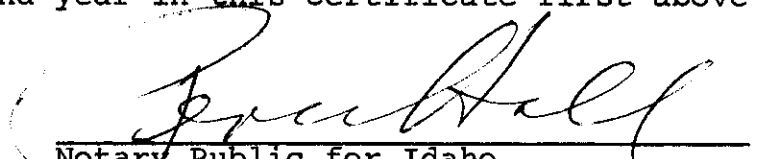
