We, D. KENNETH CHRISTENSEN and THOMAS M. BROWN, do hereby certify that we are, respectively, the President and Assistant Secretary of Moose Creek Ranch, Inc., a Minnesota corporation, and that at a meeting of the stockholders of said corporation duly called and held on March 7th, 1964, in accordance with the statutes of the State of Minnesota and the By-laws of said corporation, the following resolutions were adopted by the vote of the holders of at least two-thirds of the outstanding shares of the corporation:

RESOLVED By the stockholders of Moose Creek Ranch, Inc. that the Articles of Incorporation of this corporation be, and they hereby are, amended by amending Article V thereof in its entirety to read as follows:

V.

The total authorized number of shares of this corporation is 150,000, all of which shall be of the par value of \$1.00 each. The amount of stated capital with which this corporation shall begin business shall be One Thousand Dollars (\$1,000.00).

FURTHER RESOLVED That the officers of this corporation be, and they hereby are, authorized and directed to make, execute, file and record, in accordance with law, a certificate evidencing the foregoing resolution and to do all acts and things necessary for making effective the amendment incorporated in the foregoing resolution.
