ARTICLE 2.

The object of this corporation shall be the promotion of religious and benevolent work as a pastoral charge of and subject to the provisions of the discipline of the Methodist Episcopal Church in the United States of America.

ARTICAE 3.

The term for which this corporation is to exist is fifty years.

The principal place of business of said corporation is <u>Teactful Vallar</u> Sach

The title of the persons making these articles of incorporation are Trustees, of whom there shall be three, to be elected annually at the Fourth Quarterly Conference of said FIRST HETHODIST EPISCOTAL CHURCH OF PEACEFUL VALLEY, IDAHO or as provided in the Discipline of said Church.

At a meeting held on the 2nd.day of January 1913, at the School House in School District No.56, for the purpose of adopting articles of incorporation in conformity with the discipline of the Lethodist Episcopal Church of the United States of America, the following persons were elected Trustees by the majority vote of all qualified electors, to held office until the next Fourth quarterly Conference, or until their successors are elected and cualified.
