

ARTICLES OF INCORPORATION OF THE  
FIRST METHODIST EPISCOPAL CHURCH OF PEACEFUL VALLEY, IDAHO.

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned, have associated ourselves together under the laws of the State of Idaho as a body corporate.

ARTICLE 1.

The name of this corporation shall be the FIRST METHODIST EPISCOPAL CHURCH OF PEACEFUL VALLEY IDAHO.

ARTICLE 2.

The object of this corporation shall be the promotion of religious and benevolent work as a pastoral charge of and subject to the provisions of the discipline of the Methodist Episcopal Church in the United States of America.

ARTICLE 3.

The term for which this corporation is to exist is fifty years.

ARTICLE 4.

The principal place of business of said corporation is

Peaceful Valley Idaho

ARTICLE 5.

The title of the persons making these articles of incorporation are Trustees, of whom there shall be <sup>Four</sup> ~~three~~, to be elected annually at the Fourth Quarterly Conference of said FIRST METHODIST EPISCOPAL CHURCH OF PEACEFUL VALLEY, IDAHO or as provided in the Discipline of said Church.

ARTICLE 6.

At a meeting held on the 2nd day of January 1913, at the School House in School District No. 56, for the purpose of adopting articles of incorporation in conformity with the discipline of the Methodist Episcopal Church of the United States of America, the following persons were elected Trustees by the majority vote of all qualified electors, to hold office until the next Fourth Quarterly Conference, or until their successors are elected and qualified.
