ARTICLES OF INCORPORATION
OF
THE TWIN FALLS TRACTOR & IMPLEMENT CO.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are of full age and are citizens of the United States and are bona fide residents and citizens of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and we do hereby certify:

I

That the name of the said corporation shall be: "The Twin Falls Tractor & Implement Co."

II

That the purposes for which said corporation is formed are:

1. To purchase, sell, and in general to deal in, implements, machinery, tractors, vehicles, and any and all articles pertaining to agriculture, in any or all of the states and territories of the United States and in foreign countries, and to acquire property for the purpose of carrying on such business.
2. To purchase and otherwise acquire, own, hold, sell, deal in, improve, lease and mortgage real estate or any interest thereon within the State of Idaho or within any of the several states of the United States and to erect, care for, maintain, extend, alter and manage buildings and other improvements thereon; to purchase and otherwise acquire, own, hold, sell, lease, mortgage and hire such personal property as may be necessary or convenient for the handling, improving, dealing in and operating its real estate or its personal property or convenient for the transaction of its general construction and engineering business.
3. To borrow and lend money and negotiate loans, draw acceptances, endorse, discount, buy, sell and deliver conditional sales contracts, bills of exchange, promissory notes, bonds, debentures,

coupons, and other negotiable instruments and securities; to issue, subscribe for, take, acquire and hold, sell, exchange and deal in shares of capital stock, including capital stock issued by it, and other stocks, bonds, obligations and securities of any government or authority or company; to give any guaranty for the payment of money or performance of any obligation or undertaking incidental or appropriate for the carrying on generally of its business; to enter into, make, perform and carry out contracts of every sort and kind with any person, firm, association or corporation, private, public or municipal or body politic and with the government of the United States or any state, territory or colony thereof or any foreign government.

The statements contained in the subdivisions numbered 1 to 3 of this paragraph shall, except where otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other subdivision but shall be regarded as independent purposes and powers. The subdivisions contained in this statement or purposes shall be construed as both purposes and powers and the enumeration thereof shall not be held to limit or restrict in any manner the general powers conferred on this type of corporation by the laws of the State of Idaho, all of which are hereby expressly claimed.

III

That the principal place of business, registered office and the location and post office address of the registered office of said corporation shall be Twin Falls in the County of Twin Falls, State of Idaho.

IV

That the term for which said corporation shall exist is fifty (50) years.

V

That the number of Directors of said corporation shall be three (3).

VI

That the amount of capital stock of said corporation shall be One Hundred Thousand and no/100 Dollars (\$100,000.00) divided into one thousand (1,000) shares of the par value of One Hundred and no/100 Dollars (\$100.00) each.

VII

That the amount of the capital stock of said corporation which has been actually subscribed is Four Hundred and no/100 Dollars (\$400.00) and the following are the names of the subscribers with their addresses, and the number and par value of the shares subscribed by each:
