The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE ONE
NAME OF CORPORATION

The name of the corporation shall be "MULKSTER & CO., INC.".

ARTICLE TWO
PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

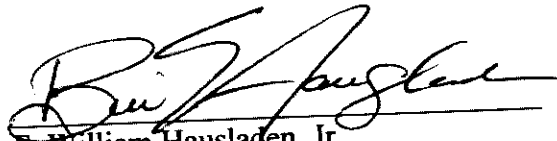
