ARTICLES OF INCORPORATION OF MEAD'S EQUIPMENT & DIESEL INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business CATE CE LARD Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is MEAD'S EQUIPMENT & DIESEL INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE IV.

The amount of total authorized capital stock of this corporation is 10,000 shares at no par value. All of said stock shall be common stock and non-assessable having equal voting rights, powers, preferences and restrictions.

ARTICLE V.

The business of the Corporation shall be managed and conducted by a Board of Directors of not less than one (1) and not more than four (4) Directors. The Board of Directors shall be elected in the manner set forth in the Bylaws.
