

ARTICLES OF INCORPORATION

of the

KNOW ALL MEN BY THESE PRESENTS; that we the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho; and we hereby certify:

FIRST. That the name of said corporation is GEM STATE RURAL PUBLISHING COMPANY LIMITED.

SECOND. That the purposes for which it is formed are to do a general printing and publishing business, to acquire and own property, both real and personal, and do all lawful things necessary in the continuing of said business.

THIRD. That the place where its principal business is to be transacted shall be Caldwell, Canyon County, Idaho.

FOURTH. That the term for which it is to exist is fifty years from and after the date of its incorporation.

FIFTH. That the number of its directors shall be five and that the names and residences of those who are appointed for the first year upon vote of majority of the members present are as follows:
