## ARTICLES OF AMENDMENT

OF

FIRST METHODIST EPISCOPAL CHURCH OF BOISE CITY.

At a regularly called meeting of the members of the First Methodist Episcopal Church of Boise City, held at said church at 10th and State Streets, Boise, Idaho, on Sunday, December 3, 1944, after due notice had been given of the purpose of the meeting, the following action was taken:

After determining that a quorum was present the meeting was called to order by Claude R. Davis.

It was duly moved, seconded and carried by an unahimous vote that the legal name of the church corporation should be changed from First Methodist Episcopal Church of Boise City to First Methodist Church of Boise City.

It was moved, seconded and carried that a certificate signed and verified by the Presiding Officer and Secretary of this meeting be made, showing compliance with the law in respect to this amendment, and that duplicates of such certificate must be made and one filed in the office of the County Recorder and one in the office of the Secretary of State, as provided for original Articles of Incorporation.

Claude R. Davis and Russell M. Ash each for himself being duly and severally sworn, says: / That the said Claude R. Davis was the Presiding Officer, and that the said Russell M. Ash was the Secretary of the meeting of members of First Methodist Episcopal Church of Boise City referred to in the above Articles of Amendment.

Articles of Incorporation of said church to change the name of the church corporation from First Methodist Episcopal Church of Boise City to First Methodist Church of Boise City was given by the Board of Trustees of said church by publication once a week for four weeks in the Idaho Pioneer, a newspaper published in Ada County, Idaho; that the foregoing Articles of Amendment set forth the true and correct action taken by the members of the church at the meeting of the members held on December 3rd, 1944, the time fixed for said meeting; and said Claude R. Davis and Russell M. Ash, Presiding Officer and Secretary of said meeting, acknowledged that they executed the foregoing instrument.
