



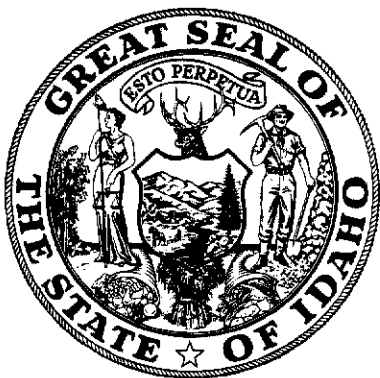
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned being of full legal age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:

I

The name of the corporation shall be WARREN A. WANAMAKER, INC.

II

The corporation shall commence operations on January 1, 1987, and the term of existence shall be perpetual.

III

The nature of the business of the corporation, its objectives and purposes shall be to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

IV

The registered office of the corporation shall be located at 1600 Lakeshore Drive, Sagle, Idaho. The mailing address of the registered office shall be 1600 Lakeshore Drive, Sagle, Idaho 83860. The initial registered agent of the corporation shall be Warren A. Wanamaker.

The total authorized number of par value shares of stock is Twenty Five Thousand (25,000). The shares have a par value of One (\$1.00) Dollar. The aggregate par value of the total authorized number of shares is Twenty-Five Thousand (\$25,000.00) Dollars. Said stock shall be of a single class.





