KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being of full age and a citizen of the United States, do this day voluntarily form a corporation under the provisions of the Idaho Business Corporation Act, and certify in writing:

1. NAME

The name of the corporation shall be Ohman Enterprises, Inc.

2. PURPOSE AND POWERS

The purposes of this corporation are to engage in any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act, and to possess and exercise all the powers and privileges granted by the Idaho Business Corporation Act or any lawful powers and privileges incidental thereto, so far as such powers and privileges are necessary or convenient to the conduct, promotion or attainment of the business or purposes of the corporation.

3. DURATION

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

4. REGISTERED OFFICE

7. MANAGEMENT

The business of the corporation shall be managed by a board of at least three (3) directors, except that if all of the shares of the corporation are owned beneficially and of record by either one (1) or two (2) shareholders, the number of directors may be less than three (3), but not less than the number of shareholders. A director shall hold office for the term for which he was named or elected and until his successor is elected and qualified. The incorporator listed in Article 6 above shall serve as the sole director until the first annual meeting of the shareholders or until their successors are elected and qualified.

8. BYLAWS

The initial bylaws of the corporation shall be adopted by the sole director. The power to alter, amend or repeal the bylaws or adopt new bylaws, subject to repeal or change by action of the shareholders, shall be vested in the sole director.
