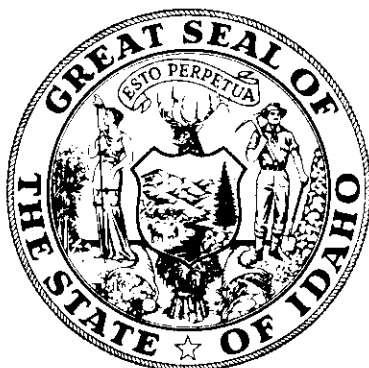

# Articles of Incorporation of

THINK FOOD, INC.

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is THINK FOOD, INC.
- SECOND:** The period of its duration is Perpetual
- THIRD:** The purpose(s) for which the corporation is organized are To operate a cash and carry wholesale food service and transact any lawful business for which corporations may be incorporated under this act.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is 250,000 of common stock, one class only with a par value of \$2.00 (two dollars) each.
- FIFTH:** The corporation will not commence business until at least -0- have been received by it as consideration for the issuance of shares.
- SIXTH:** Cumulative voting of shares of stock is ☒ authorized.
- SEVENTH:** Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: none.
- EIGHTH:** Provisions for the regulation of the internal affairs of the corporation are: To be set forth in the Bylaws as permitted under this Act.
