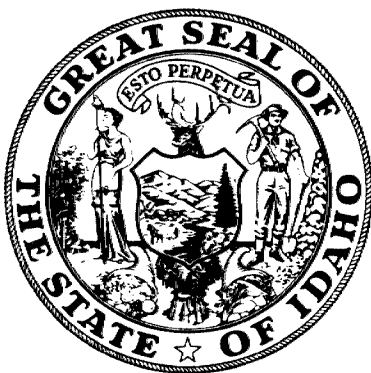

Incorporation:

ARTICLE I.

The name of the corporation is:

The period of duration is perpetual.
