ARTICLES OF INCORPORATION OF NEW SAINT ANDREWS COLLEGE, INC. STATE OF DAHO

We, the undersigned persons, acting as the incorporators of a corporation under the provisions of Title 30, Chapter 3 of the Idaho Code commonly known as the Idaho Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of this corporation shall be: New Saint Andrews College, Inc.

ARTICLE II - DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes.

To facilitate these purposes, this corporation is organized to provide Christian college level instruction and training of students for the purpose of improving or developing their capabilities. The corporation shall have a regularly scheduled curriculum, a regular faculty, and a regularly enrolled body of students in attendance at a place where the educational activities are regularly carried on.

ARTICLE IV- LIMITATIONS

No part of the net earnings of this corporation shall inure to the benefit of any private member or individual. No substantial part of the activities of the organization will be used to carry on propaganda, or otherwise attempt to influence legislation, (except as otherwise provided in subsection (h) of Section 501 of the IRC). This corporation will not be used to participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE V - POWERS

The corporation shall have all powers granted by law necessary and proper to carry out its above-stated purposes, consistent with its qualification under Section 501(c)(3).

ARTICLE VI - BOARD OF DIRECTORS

The internal affairs of this corporation shall be managed by a board of directors elected by action of the Board of Directors pursuant to the Bylaws of the corporation. All other provisions for the regulation of the internal affairs of this corporation shall be set forth in the Bylaws.

ARTICLE VII - MEMBERSHIP

The corporation shall not have members.

ARTICLE VIII - ADDRESS AND REGISTERED AGENT

ARTICLE X - AMENDMENTS

Amendments to these Articles of Incorporation may be made at any annual meeting or special meeting of the board of directors, and must be made in the following manner:

Amendments shall be adopted at a meeting of the board of directors upon receiving the vote of a majority of the directors in office. Any number of amendments may be submitted and voted upon at any one meeting. A written notice of the meeting, that shall include as a purpose the intent to amend the bylaws, shall be provided.

ARTICLE XI - TERMINATION AND FINAL DISTRIBUTION

In the event that this corporation ceases to function as a non-profit corporation or is dissolved for any reason, its assets shall be distributed to such organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such a manner as the Board of Directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said court shall determine to be consistent with the purposes of this corporation.

ARTICLE XII - INDEMNIFICATION

The Corporation will indemnify any director, officer, employee, or agent of the corporation made a party, or threatened to be made a party, to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative (other than one by or in the right of the corporation to procure a judgment in its favor, brought to impose a liability on such person for an act alleged to have been committed by such person in his or her capacity as director of officer of the corporation, or as director, officer, employee or agent of any other entity when he or she served at the request of the corporation), by reason of fact that he or she is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust, or Indemnification shall include judgments, amounts paid in settlement and reasonable expenses, including attorney fees, actually and reasonably incurred as a result of such action, suit or proceeding or any appeal therein. Indemnification shall occur if such person is either successful in his or her defense or if the proceeding is terminated by settlement, and if such person acted in good faith in the reasonable belief that such action was in the best interests of the corporation. In criminal actions or proceedings, indemnification shall occur only if such person had reasonable grounds for belief that such action was lawful. No indemnification shall exist for criminal acts committed by such person.
