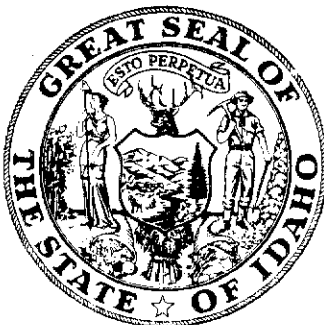

## ARTICLES OF INCORPORATION OF CIRCLE "C" PARTNERS, INC.

The undersigned, acting as incorporator under the Idaho Business Corporation Act, adopts the following articles of incorporation:

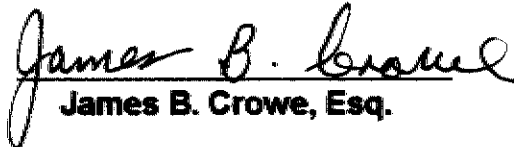
