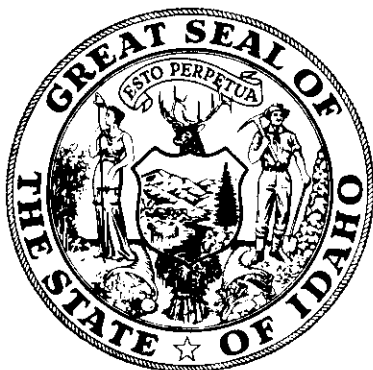

ARTICLES OF INCORPORATION  
OF  
HAROLD Q. NOACK, JR., P.A.  
PROFESSIONAL LAW CORPORATION

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be HAROLD Q. NOACK, JR., P.A., PROFESSIONAL LAW CORPORATION.

ARTICLE II

The period of existence and duration of the life of this corporation shall be until the combined death or disqualification of Harold Q. Noack, Jr., and any other shareholder as required under Idaho Code Section 30-1309A.

ARTICLE III

This corporation is formed to carry out the practice of law and for the investment of funds in real estate, mortgages, stocks, bonds, or any other type of investments or the ownership of real or personal property which is necessary for the rendering of professional services or for any other purpose allowed under Idaho Code Section 30-1307.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$25,000.00, divided into 25,000 shares of non-assessable common stock of the par value of \$1.00 per share.

ARTICLE V

The principal place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho, at

Suite 254, 910 Main, Boise, Idaho, which is hereby designated as the address of its registered office. Harold Q. Noack, Jr., is the registered agent.

#### ARTICLE VI

The name and post office address of the incorporator is Harold Q. Noack, Jr., P. O. Box 1525, Boise, Idaho 83701.

#### ARTICLE VII

The management of this corporation shall be vested in one (1) director, Harold Q. Noack, Jr., whose address is P. O. Box 1525, Boise, Idaho 83701.

#### ARTICLE VIII

A shareholder of this corporation shall not sell or transfer his shares in this corporation except to another individual who is eligible to be a shareholder of this corporation and said sale or transfer shall be made only after the same has been approved at a stockholder's meeting specifically called for such purpose by such proportion not less than a majority of the outstanding stock. At the shareholders' meeting held for the above purpose, the shares of stock held by the shareholder proposing to sell or transfer his shares shall not be voted or counted for any purpose unless all the stockholders consent that such stock be voted.

#### ARTICLE IX

The private property of the shareholders of this corporation shall not be subject to the payment of the corporate debts in any amount or to any extent whatever.
