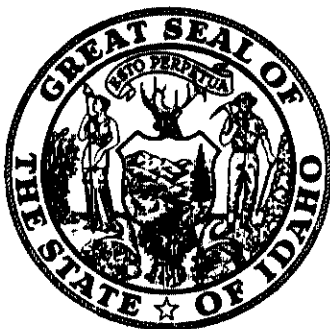
CERTIFICATE OF INCORPORATION OF

We, the undersigned, incorporators, for the purpose of forming a corporation under the Idaho Nonprofit Corporation Act, do hereby certify and adopt in duplicate the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation hereby incorporated is Latah County Deputy Sheriff's Association, Inc..

ARTICLE II.

The corporation is a nonprofit corporation.

ARTICLE III. DURATION

The duration of the corporation is perpetual.

ARTICLE IV. PURPOSES

The purpose or purposes for which the corporation is organized are:

To conduct a professional association with the following goals and objectives:

1. To improve and maintain positive public relations with the Latah County Sheriff's office.
2. To improve and maintain morale within the Latah County Sheriff's office.
3. To encourage adequate training.
4. To negotiate salary and work condition contracts.
5. To assist in the campaigns of those political candidates, excepting the office of Sheriff of Latah County, whose election to office is determined by the membership to be in the best interests of the Association.
6. To pursue any and all other lawful purposes.

ARTICLE V. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation in the State of Idaho is 5th Street and Van Buren, P.O.

Box 8068, Moscow, Idaho 83843; and the name of its initial registered agent at said address is Heather Browning.

ARTICLE VI. DIRECTORS

The number of directors of the corporation shall be fixed as provided in the By-Laws, and may be changed from time to time by amending the By-Laws, as therein provided, but the number of directors shall not be less than three.

The first directors of the corporation shall be four in number and their names and post office addresses are as follows:
