ARTICLES OF INCORPORATION

FIRST. - The name of this Corporation is Distribution Direct, Inc.

SECOND. - The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the general Corporation Law of Idaho.

THIRD. - The duration of this Corporation shall be perpetual.

FOURTH. - The registered office of this Corporation shall be in Glenns Ferry, Elmore County, Idaho. The P. O. address shall be Box 553, Glenns Ferry, Idaho, 83623.

FIFTH. - The amount of the total authorized capital stock of this Corporation is 1,000 shares of \$5.00 par value stock. \$50000.00 total.

SIXTH. - The names, addresses and number of shares subscribed by the incorporators are as follows:

SEVENTH. - All of the issued stock shall be subject to the following restriction on transfer: Each stockholder shall offer to the Corporation or to other stockholders of the Corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.

EIGHTH. - The stockholders and directors shall have power to hold their meetings and keep the books, documents and papers of the Corporation at such places as may be from time to time designated by the Bylaws or by resolution of the stockholders or directors, except as otherwise required by the laws of Idaho.

NINTH. - The directors shall have power to make and to alter or amend the Bylaws; to fix the amount to be reserved as working capital, and to authorize and cause to be executed, mortgages and liens without limit as to the amount, upon the property and franchise of the Corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the directors shall have the authority to dispose, in any manner, of the whole property of this Corporation.
