One Thousand Nine Hundred Fifty-cir and is duly recorded on Film No. 96 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at in the County of the Falls and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service. Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
of the Tyler St. Baptist Church
283 Tyler, Twin Falls, Idaho, Inc.

Reposing our faith in the Lord Jesus Christ for salvation, and believing in the teaching and practice of the Baptists and those great distinctive principles for which they have ever stood, namely:

- I. The Lordship of Jesus Christ,
- 2. The Bible the standard of faith and practice,
- 3. Regenerated church membership,
- 4. Believer's baptism by immersion,
- 5. Progressive sanctification,
- 6. Soul liberty,
- 7. Congregational church polity,
- 8. Seperation of church and state,

We, Earl E. Terpening, Ray Claiborne, Halph Likes, and Jerry Moore all of Twin Falls County, State of Idaho, citizens of the United States, natural persons of full age, and duly elected trustees of the Tyler St. Baptist Church, Twin Falls, Idaho together with other voting members of said church, associate ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho, and for this purpose we do

hereby certify and declare:

- I CORPORATE NAME: The name of this corporation is and shall be Tyler St. Baptist Church, of Twin Falls, Idaho, Inc.
- II LOCATION AND POST OFFICE ADDRESS: The location and post office address of this corporation shall be 288 Tyler St., Twin Falls, Idaho.

III PURPOSES:

- a. Preach the gospel and the pure word of God,
- b. To build the local organization and to foster the founding and growth of other churches within the state.
- c. To educate the believers by establishing Sunday Schools, young peoples meetings, summer camps, schools, colleges, seminaries, and other institutions for the education and training of christians which the local church sees fit,
- d. To co-operate with others in missionary programs, and or to organize missionary societies, that the word may be taken to all nations and peoples,
- e. To provide such ministry and institutions as are needed for the care of the poor, orphans, sick, disabled and aged persons.
- IV BURATION: This corporation shall be perpetual in duration.

V INCORPORATION: This corporation is a membership corporation without capital stock, and is not organized for pecuniary profit.

VI MEMBERSHIP:

- a. Membership is to be made up of regenerate persons, professing faith in Christ as Saviour, immersed and of their own free will united to the church.
- b. Members who no longer attend, unruly members, and members holding false doctrines may be excluded (Matt. 18:15-18; II Tim. 3:6;)
- c. No member who has his name on the inactive list shall have a right to vote.
- VII THE POWERS OF THE CORPORATION: The church through its regularly elected trustees, has power to acquire land and buildings, to buy, sell, morgage, build, or remove buildings, and to purchase all needed equipment and supplies. The Tyler St. Baptist Church hereby reserves the right to restrict and limit the trustees in their business transactions for the church, according to the constitution and bylaws of the church.

VIII ANNUAL BUSINESS MEETING:

- a. The annual business meeting shall be held on a posted date between November 1 and December 15.
- b. Announcement of the business meeting is to be

posted three weeks or announced two weeks from the pulpit.

- c. A quorum shall be eight active members.
- d. The trustees shall be elected by the membership of the church. The term of office shall be for three years, one new trustee being elected to the board each year.
- e. The trustee shall hold office till his successor is elected and qualified.
- f. No trustee shall continue in office whose name has been excluded or put on the inactive list.
- g. At the printing of these articles of incorporation, three trustees have been elected whose names and addresses, along with that of the pastor, are herein after set forth;
