ARTICLES OF AMENDMENT

Pursuant to the provisions of Section 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is changed from Association for Retarded Citizens of Ada County, Inc., to The Arc, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted at a special meeting (at which a quorum was present) of the members of the undersigned corporation held on August 25, 1992, in the manner prescribed by the Idaho Nonprofit Corporation Act:

I.

The name of this corporation shall be The Arc, Inc. This corporation shall be a nonprofit corporation.

IX.

In the event The Arc, Inc. is dissolved as a corporation within the State of Idaho and ceases to exist for the stated purposes, such certificate of dissolution shall be filed with the Secretary of State, according to the statutes of the State for the dissolving of nonprofit corporations, and all property and assets shall revert to any agency serving the mentally retarded which has been granted exemption from the Federal Income Tax under the provisions of Section 501(c)3 of the Internal Revenue Code of 1986, or any corresponding provision of any future revenue code, or to the State or Federal Government for exclusively public purposes.

Under no circumstances shall any of the property or assets of the corporation during the existence and/or upon the dissolution thereof go and be distributed to any officer, member, or subsidiary of the corporation.
