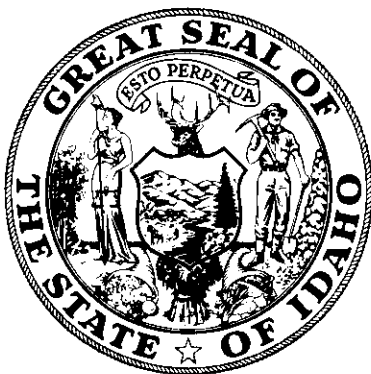

ARTICLES OF INCORPORATION
OF
IDAHO SPEECH, LANGUAGE, HEARING ASSOCIATION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for this nonprofit corporation.

I.

The name of this corporation shall be IDAHO SPEECH, LANGUAGE, HEARING ASSOCIATION, INC.

II.

The corporation shall be a nonprofit corporation.

III.

The period of existence and duration of the life of this corporation shall be perpetual.

IV.

The object and purpose of this corporation shall be as follows:

- a) To improve the educational opportunities and rehabilitation of those handicapped by communicative disorders.
- b) To implement and advance professional preparation in speech, language pathology, and audiology - including post-graduate education.
- c) To provide Members with continued professional growth in the fields of speech, language, and hearing.
- d) To promote a closer working relationship between Members and other professionals concerned with

communicatively handicapped persons.

- e) To adopt and practice ethical principles in the field of communicative disorders.
- f) To promote between Members and the general public a mutual exchange of information concerning communicative disorders.

V.

The address of the initial registered office of this corporation is 1207 Fort Street, Boise, Idaho, 83702, and the name of the initial registered agent at such address is Michael F. Anderson.

VI.

The first Board of Directors shall consist of six (6) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-Laws.
