

ARTICLES OF INCORPORATION OF THE GREENWOOD AVENUE IRRIGATION

KNOW ALL MEN BY THESE PRESENTS, That, we whose names are here-
to subscribed, do, under and by virtue of the laws of the State of Idaho
hereby organize, constitute, associate^p ourselves and such other persons
as may hereafter become associated with us, into a body corporate and
politic, and to that end, execute this instrument, which, when certified,
filed and recorded as required by law, shall constitute the articles
of incorporation of the GREENWOOD AVENUE IRRIGATION COMPANY, LIMITED,
of Payette, Idaho, and we do hereby certify:

FIRST, That the name of this corporation is the Greenwood Avenue
Irrigation Company, LIMITED.

Second, That the purpose for which it is formed and its powers
under its corporate name and organization is to own, manage and direct
and establish and maintain lateral ditches and irrigation canals, and
carrying and distributing of water to its share holders and generally
to do all of the things incident to or connected with the irrigation of
land and town lots.

Third, That the place where its principal business is to be
transacted is Payette, Canyon County, Idaho.

Fourth, That the term for which this corporation shall exist is
fifty years.

Fifth, That the number of the directors of this corporation shall
