BENNY D. LOBE and SHIRLEY R. LOBE, President and Secretary, respectively, of House of Pancakes, Inc., upon being duly sworn, certify and declare as follows:

I.

That they are the President and Secretary, respectively, of the Corporation.

II.

That they are the only shareholders of the Corporation.

III.

That pursuant to the provisions contained in Section 30-146 (5), Idaho Code, the shareholders of the Corporation took corporate action by unanimous written consent to amend the Articles of Incorporation, which amendment is as follows:

Article VII of the Articles of Incorporation, reading as follows:

"Directors

The board of directors of said corporation shall be four (4) in number. The initial directors who shall serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

was repealed and replaced by a new Article VII, reading as follows:

"VII. DIRECTORS

The Board of Directors of said Corporation shall consist of not less than three nor more than five members, to be determined from time to time by
