ARTICLES OF INCORPORATION

Williams Printing, Inc. 59

1. The name of the corporation is Williams Printing, Inc.

2. The period of its duration is perpetual.

3. Its purposes are print, publish and distribute written oral and visual communications and to transact any or all lawful business.

4. The corporation shall have the authority to issue 1,000 shares of common stock. Each share shall have a par value of \$1.00 and the total par value of all of the shares shall be \$1,000.00.

5. The holders of the stock of this corporation shall be entitled to sell their shares of stock on the open market subject to the conditions that the holders of such stock must, before offering the stock for public sale, first offer the stock to the corporation, and second, if the corporation does not purchase the stock so offered, must offer the stock to the remaining shareholders at a price not exceeding the fair value of the stock, and subject further to the right of the corporation to re-purchase, then the rest of the stockholders shall have the right to purchase the stock at a price not exceeding its fair value at the end of the month preceding the month in which the shareholder died.

6. The location and post office address of the corporation is 1302 N. Harding St., Boise, ID 83706. The name of the initial registered agent of the corporation at this address is Justin Leon Williams.

7. The number of directors constituting the initial board of directors shall be one (1) and their names and addresses are as follows:

Every director and officer shall be indemnified against all liabilities, civil and criminal, incurred in relation to his duties, including all reasonable expenses of defense, except to the extent that he shall have been finally adjudged to be liable for negligence or misconduct in the matters out of which the liabilities arise.

10. The private property of the shareholders shall not be subject to the payment of any corporate debts. The shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation.
