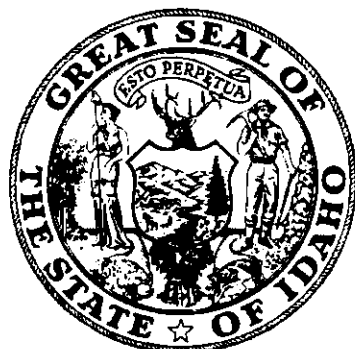
CERTIFICATE OF MERGER OR CONSOLIDATION

MERGER AGREEMENT

This Agreement made this 15th day of December, 1979, by and between Twin Falls Multiple Listing Service, Inc., a Corporation organized and existing under the laws of the State of Idaho, having its principal office at Twin Falls, Idaho, and Multiple Listing Service of Twin Falls, Inc., a Corporation organized and existing under the laws of the State of Idaho, having its principal place of business at Twin Falls, Idaho.

RECITALS

1. The Board of Directors of the respective corporations deem it desirable and in the best interest of the corporations and the shareholders that Twin Falls Multiple Listing Service, Inc., be merged into Multiple Listing Service of Twin Falls, Inc.

For the reason set forth above, and in consideration of the mutual covenants and promises of the parties hereto, the constituent corporations agree, pursuant to Idaho Code §30-1-71 that Twin Falls Multiple Listing Service, Inc. shall be merged into Multiple Listing Service of Twin Falls, Inc., as a single corporation; and the parties hereto hereby agree to and prescribe the terms and conditions of such merger and the method of carrying it to effect, as follows:

Section 1. Multiple Listing Service of Twin Falls, Inc., to be Surviving Corporation.

Twin Falls Multiple Listing Service, Inc. shall be merged into Multiple Listing Service of Twin Falls, Inc. and the corporate existence of Twin Falls Multiple Listing Service, Inc. shall cease and the corporate existence of Multiple Listing Service of Twin Falls, Inc. shall continue under the name Multiple Listing Service of Twin Falls, Inc. and Multiple Listing Service of Twin Falls, Inc. shall become the owner, without other transfer, of all the rights and property of the constituent corporations, and Multiple Listing Service of Twin Falls, Inc. shall become subject to all the debts and liabilities of the constituent corporations in the same manner as if Multiple Listing Service of Twin Falls, Inc. had itself incurred them.

Section 2. Principal Office.

The principal office of Multiple Listing Service of Twin Falls, Inc. shall remain the principal office of the corporation following this merger.

Section 3. Objects and Purposes.

The nature of the business and the objects and purposes proposed to be transacted, promoted, and carried on by the corporation following the merger are the same as listed in the Articles of Incorporation for Multiple Listing Service of Twin Falls, Inc.

Section 4. Articles of Incorporation.

The Articles of Incorporation of Multiple Listing Service of Twin Falls shall be changed as reflected in the Articles of Incorporation of Multiple Listing Service of Twin Falls, Inc. attached as Exhibit "A."

Section 5. Present By-Laws.

The present By-Laws of Multiple Listing Service of Twin Falls, Inc. insofar as not inconsistent with this agreement of merger, shall be the By-Laws of the corporation following the merger until altered, amended or repealed as therein provided.

Section 6. Method of Converting Shares.

Immediately upon this agreement of merger becoming effective, the certificate of the constituent corporation shall, without any other action on the part of the respective holders thereof, become and be converted into shares of stock of Multiple Listing Service of Twin Falls, Inc.

ARTICLES OF MERGER




The plan of merger attached hereto as Exhibit "A" was approved by the stockholders of each of the undersigned corporations in the manner prescribed by statute.
